



 This Indenture made this eighth day of April in the
 year one thousand eight hundred and eleven Be-
 tween John Dowash and William Fullerton both of
 North Huntingdon Township Westernland County
 and state of Pennsylvania. Witnesses that the said
 John Dowash for and in consideration of the sum of twenty five
 dollars to him in hand paid by the said William Fullerton the
 receipt of which is hereby acknowledged hath granted bargain
 ed and sold and by these presents doth for himself and his heirs
 grant bargain and sell to the said William Fullerton and his
 heirs and assigns a certain part of the plantation which
 the said John Dowash now lives on near the East end of said
 place including a coal Bank Beginning at a Maple tree where
 by part of said plantation North line or perches to an Iron wood
 sapling thence east line or perches to a white oak South South
 line or perches to a Maple sapling and west line or to the place
 of beginning containing one hundred and forty four perches to
 near and to hold the said described piece of land and premises
 with the appurtenances unto the said William Fullerton his heirs
 and assigns to the only proper use benefit and behoof of him the

said William Fullerton his heirs and assigns forever and it is further agreed on by the parties herunto that the said William Fullerton his heirs and assigns shall have liberty without hinderance or molestation to make a road through the wood land of said John Dowd whereon the said Fullerton may find the most convenient and occupy the same by passing to and from the said coal bank forw and the said John Dowd reserves the prior privilege of passing through the said piece of land hereby sold to and from his coal bank and the said John Dowd for himself and his heirs doth covenant promise and agree to and with the said William Fullerton his heirs and assigns by these presents that he the said John Dowd waives the said land and promises with the appurtenances hereby granted unto the said William Fullerton his heirs and assigns against himself the said John Dowd his heirs or assigns and against all and every other person or persons lawfully claiming or to claim well by these presents warrant and forever defend in witness whereof the said John Dowd hath hereunto set his hand and affixed his seal the day and year first herein written

This Indenture made the fourteenth day of February in the year
Thomas Wilson of our Lord one thousand eight hundred and sixteen between
To Thomas Wilson of Daleu Township in the County of Westernland
John Hutton and State of Pennsylvania and Elizabeth his wife of the one part
and John Hutton of the County of Westernland and State aforesaid
of the other part. Whereas a certain tract of land was surveyed to William
Wilson in pursuance of a warrant to him dated the 8th November 1784 sit
uate in Daleu Township and County aforesaid containing three hundred acres
and the usual allowance &c and (PAGE 45) and whereas the said William Wilson
died seized thereof having made his last will and testament dated the 7th
March 1796 and therein devised the said tract of land with the appurtenances
to his sons the said Thomas and George Wilson to whom a patent from the land
office issued for the same dated 7th December 1810 and a vicible partition
thereof having been made between them by certain metes and bounds agree
ably to the provisions of the last will and testament and deeds of release
having been duly executed by William Wilson Thomas Young and Mary
his wife Samuel McClelland and Ann his wife Martha Wilson Agnes Wilson
Jane Elliott and George and Rachel Wilson the heirs and representatives of the said
William Wilson deceased to the said Thomas Wilson his heirs and assigns
for the part of said land with the appurtenances happening to him by the
aforesaid partition the title thereto became vested in him his heirs and
assigns And whereas a Town called New Daleu hath been laid off on
part of said premises by the said Thomas Wilson in lots numbered
from one to forty eight inclusive agreeably to a Map or plan made by
